CALL TO ORDER:

THE MEETING WAS CALLED TO ORDER AT THE HOUR OF 7:01 P.M. BY MAYOR ADAMS. MAYOR ADAMS LED THE PLEDGE OF ALLEGIANCE. COUNCILMAN LOUDEN OFFERED THE INVOCATION.

MAYOR ADAMS WELCOMED THE COGHILL'S AND SAID THEY COULD ADDRESS THE COUNCIL DURING JOHN WELCH'S REPORT. MAYOR ADAMS THEN ASKED JENNIFER BEACH IF SHE WOULD LIKE TO ADDRESS THE COUNCIL.

MS. BEACH SAID SHE WAS RUNNING FOR COUNTY JUDGE EXECUTIVE AND GAVE A 10 MINUTE PRESENTATION ON HOW SHE WOULD CLEAN UP THE COUNTY; THAT THERE NEEDS TO BE BETTER LEADERSHIP WITHIN THE COUNTY; AND HOW THE CITY AND COUNTY NEED TO WORK TOGETHER.

OLD BUSINESS

MAYOR ADAMS SAID THERE WAS A SPECIAL MEETING HELD EARLIER TODAY TO DISCUSS THE SPLASH PARK AND AFTER THE MEETING MR. KNIGHT; COUNCILMAN GORDON; COUNCILMAN CRAIG; THE GENTLEMEN FROM DAVID WILLIAMS & ASSOCIATES AND MYSELF MEET AT THE WORK SITE TO GET IDEAS OF HOW THE SPLASH PARK WOULD LOOK AND WHERE THE PUMP HOUSE NEEDED TO BE BUILT.

MAYOR ADAMS SAID AT THE LAST MEETING COUNCIL MADE A MOTION TO ABATEMENT 901 6TH STREET BASED UPON THE RECOMMENDATION FROM THE CODE ENFORCEMENT BOARD AND THAT THIS MOTION NEEDS TO BE RESCINDED DUE TO AN CLINICAL ERROR.

THE MOTION WAS MADE BY COUNCILMAN LOUDEN AND SECONDED BY COUNCILMAN GORDON AND DULY CARRIED TO RESCIND THE MOTION TO ABATE 901 6TH STREET; AND TO HALT ALL ABATEMENT ACTIONS AT 901 6TH STREET; UNTIL FURTHER RECOMMENDATION FROM THE CODE ENFORCEMENT BOARD.

MAYOR ADAMS STATED THAT ONCE AGAIN POINT PARK LOOKS BAD DUE TO FLOODING. THE CIVIL WAR EVENT IS LATER THIS MONTH AND WE MAY HAVE ANOTHER COMMUNITY CLEAN UP DAY BEFORE THE EVENT. MAYOR ADAMS WILL ANNOUNCE THE DATE AND TIME OF THE COMMUNITY CLEAN UP DAY AT A LATER DATE ON THE CITY'S FACE BOOK PAGE AND WEBSITE.

NEW BUSINESS

THERE WAS NO NEW BUSINESS.

DEPARTMENT REPORTS:

A. CODE ENFORCEMENT – JOHN WELCH SAID THAT WALTER COGHILL IS TRYING TO FIX HIS PROPERTY AT 502 PARADISE ALLEY AND AT THE LAST COUNCIL MEETING IT WAS APPROVED TO ABATE THIS PROPERTY. THE COGHILL'S CAME TO THE CODE ENFORCEMENT MEETING EARLIER TODAY AND ASKED IF THE ABATEMENT COULD BE RESCIND.

MAYOR ADAMS SAID THE COGHILL'S WANT TO REPAIR THE HOUSE AT 502 PARADISE ALLEY AND SOMETIME AGO A PAYMENT WAS MADE TO A LOCAL ROOFING COMPANY TO FIX THE ROOF AND THE REPAIRS WERE NEVER MADE. THE ROOFING COMPANY SAID THEY RETURNED THE CHECK TO THE OWNERS ABOUT 3 WEEKS AGO AND THE COGHILL'S CLAIM THEY NEVER RECEIVED THE CHECK AND NOW THE ROOFING COMPANY SAID THEY WILL START WORKING ON THE ROOF THIS WEEK. MAYOR ADAMS THEN ASKED MARY COGHILL IF SHE WOULD LIKE TO ADDRESS THE COUNCIL.

MS. COGHILL SAID HER FATHER WAS TURNING THE PROPERTY OVER TO HER. SHE HAS AN EMAIL FROM THE ROOFER, JASON, EXPLAINING THAT FOR LAST 75 DAYS HE HAS TRIED FIX THE ROOF BUT, DUE TO WEATHER HE HAS NOT BEEN ABLE TO COMPLETE THE WORK, HE NEEDS 3 DAYS OF GOOD WEATHER. MS. COGHILL SAID ALL THE MATERIALS HAS BEEN ORDERED AND DELIVERED.

MAYOR ADAMS ASKED COUNCIL IF THEY WOULD LIKE TO RESCIND THE MOTION TO ABATEMENT THE PROPERTY AT 502 PARADISE ALLEY.

THE MOTION WAS MADE BY COUNCILWOMAN FRANKLIN AND SECONDED BY COUNCILMAN DICKOW AND DULY CARRIED TO RESCIND THE MOTION TO ABATE 502 PARADISE ALLEY; AND TO HALT ALL ABATEMENT ACTIONS AT 502 PARADISE ALLEY; UNTIL FURTHER RECOMMENDATION FROM THE CODE ENFORCEMENT BOARD.

COUNCILWOMAN FRANKLIN ASKED MR. WELCH IF THE ROOF IS FIXED WILL THE HOUSE BE ON THE RIGHT TRACK.

MR. WELCH REPLIED YES, THE ROOF IS THE MAIN PROBLEM.

MAYOR ADAMS SAID HE WANTED THE COGHILL'S TO UNDERSTAND THERE MAY BE MORE PROBLEMS OTHER THAN TO ROOF AND WILL HAVE TO BE ADDRESSED.

COUNCILMAN LOUDEN SAID THE COGHILL'S WILL STILL HAVE TO PAY THE FINE OF \$1,500.

MR. WELCH SAID A HEARING WAS HELD TO GIVE THE PUBLIC A CHANCE TO ASK QUESTIONS CONCERNING THE POSSIBLE RE-ZONING OF SEVERAL PROPERTIES ALONG 11TH STREET. THE REZONING FROM THE CURRENT R-2 ZONE TO A LIGHT INDUSTRIAL ZONE I-1 WAS SUGGESTED AS IT WOULD ALLOW THE P&Z TO UTILIZE A PROVISION UNDER THAT ZONING DESIGNATION FOR A CONDITION USE PERMIT FOR ANY COMMERCIAL USES PROPOSED.

MR. BURGESS SUGGESTED THE CITY TO HAVE AREAS OF MIXED ZONING.

COUNCILMAN CRAIG SAID THAT P&Z NEEDS TO DRAFT AN ORDINANCE THAT DEFINES MIXED ZONING AND PRESENT TO COUNCIL.

MR. WELCH SAID THERE WAS A SPECIAL P&Z MEETING HELD TO BRING EVERYONE UP TO DATE ON THE ISON'S PROPOSAL FOR HIGHLAND HOUSE B&B.

B. TEEN COUNCIL – ASHLEY SPENNEBERG SAID ON APRIL 12TH THE PLTW WILL HAVE THEIR WHITE COAT CEREMONY; ON APRIL 16TH JCTC IS HOSTING THE ACT TESTING; FBLA IS GOING TO THE STATE COMPETITION APRIL 16TH-20TH; AND PROM IS MAY 5TH.

SAVANNAH HILL SAID THE JUNIOR SENIOR TRIP IS IN 6 WEEKS AND TO RAISE MONEY CHRISTIAN ACADEMY IS HOSTING A 5K RUN AT BUTLER PARK ON SATURDAY, APRIL 21ST AT 9:00 A.M.; REGISTRATION AND SHIRT IS \$25 FOR ADULTS AND \$15 FOR CHILD 12 AND UNDER.

- **C. PUBLIC WORKS** RON KNIGHT, PUBLIC WORKS SUPERVISOR, HAD NOTHING TO REPORT.
- **D. UTILITIES** BILL OSBORNE, UTILITIES SUPERVISOR, SAID ON APRIL 1ST CARROLLTON UTILITIES RECEIVED THEIR FIRST GAS FROM THE MORGAN STANLEY PROJECT; THE DOC IS UNDERWAY AND EXPECT TO MAKE THE FINAL POUR ON THE WALLS OF THE LARGE SHED TOMORROW AND THEN START ON THE MAIN BUILDING; CARROLLTON UTILITIES IS WORKING ON ENGINEERING PLANS TO RELOCATE A SECTION OF GAS AND SEWER LINES NORTH OF KU PLANT FOR NUCOR; THE GREENSAND BUILDING IS 90% COMPLETED; AND CARROLLTON UTILITIES IS APPLYING FOR AN ECONOMIC DEVELOPMENT GRANT. CARROLLTON UTILITIES IS ELIGIBLE FOR THE GRANT DUE TO ALL THE INDUSTRIAL DEVELOPMENT IN OUR AREA NUCOR, CABOT, KU, AND OTHERS.
- **E. CCCDC** GARY MATHIS REPORTED THAT CARROLL COUNTY WAS AWARDED TO BE A PART OF THE OPPORTUNITY ZONE PROGRAM WHICH RAISES FUNDS FOR CAPITAL PROJECTS; THE CITY OF LOUISVILLE IS A PART OF THE SAME PROGRAM. THE SIDEWALK PROJECT AT BUTLER PARK IS ON A VERY SLOW START; SO FAR ONLY

AROUND \$100 HAS BE DONATED AND NEED TO RAISE \$3,000. MR. MATHIS HAS BEEN WORKING WITH GREG BECK, DISPATCHED SUPERVISOR AND TIM MITCHELL, ASSISTANT CHIEF OF POLICE, WITH THE CMRS GRANT. ALSO, MR. MATHIS SAID HE WAS LOOKING INTO THE US BOATING GRANT FOR \$10,000.
