CALL TO ORDER:

THE MEETING WAS CALLED TO ORDER AT THE HOUR OF 7:00 P.M. BY MAYOR ADAMS. MAYOR ADAMS LED THE PLEDGE OF ALLEGIANCE. CHAPLAIN TIM POLLEY OFFERED THE INVOCATION.

RECOGNITION OF GUESTS:

JT SHAW ROCKY CHANDLER MICHAEL SAINT PAT HILL LEAH HILL

MAYOR ADAMS ASKED MR. SHAW IF HE WOULD LIKE TO ADDRESS THE COUNCIL.

JT SHAW

HE WANTED TO FORMALLY INTRODUCE HIMSELF AS A CANDIDATE FOR CARROLL COUNTY SHERIFF. MR. SHAW SAID HE HAD NEW PLANS AND IDEAS FOR THE COUNTY AND WANTED THE COUNTY AND CITY LAW ENFORCEMENTS TO WORK TOGETHER AS ONE TEAM. MR. SHAW STATED HE WOULD LIKE TO TALK WITH EVERYONE. IF ANYONE HAD ANY QUESTIONS OR CONCERNS PLEASE FREE TO CALL HIM AT 502-525-8989 OR STOP BY HIS HOUSE AT 706 5TH STREET, CARROLLTON, KENTUCKY.

MAYOR ADAMS ASKED MR. CHANDLER IF HE WOULD LIKE TO ADDRESS THE COUNCIL.

MR. CHANDLER REPLIED NO.

MAYOR ADAMS ASKED MR. SAINT IF HE WOULD LIKE TO ADDRESS THE COUNCIL.

MICHAEL SAINT

SAID HE MOVED HERE 5 YEARS AGO HOPING FOR A BETTER PLACE TO LIVE AND CARROLLTON GAVE HIM A NEW BEING. HE HAS SEVERAL GOOD IDEAS HE WANTS TO SHARE WITH COUNCIL BUT WOULD TAKE EXTREME AMOUNT OF TIME SO HE WOULD LIKE TO MEET WITH EVERYONE AT A LATER TIME.

MAYOR ADAMS ASKED MR. HILL IF HE WOULD LIKE TO ADDRESS THE COUNCIL.

PAT HILL

ASKED MAYOR ADAMS WHEN THE SIDEWALK WAS GOING TO BE REPAIRED IN FRONT OF HIS PROPERTY AND THAT THERE WAS WATER IN HIS BASEMENT FROM THE SIDEWALK BEING DAMAGED.

MAYOR ADAMS SAID SOMETIME BETWEEN APRIL AND JUNE HE WOULD WORK ON GETTING A LIST TOGETHER FOR THE SIDEWALKS THAT NEED REPAIRS AND HE WOULD LOOK AT MR. HILL'S BASEMENT FOR FURTHER DAMAGE .

MAYOR ADAMS REPORTED THERE WAS AN AD RAN FOR CLOSED BIBS FOR THE CROWN VITORIA AND THERE WERE NO BIDS. ONE WAY THE CITY COULD DISPOSE OF THE VEHICLE IS TO TAKE IT TO THE JUNK YARD AND SCRAP IT. FIRST WE NEED A SET AN AMOUNT AND COUNCIL HAS TO APPROVE THE AMOUNT AND THE VEHICLE WOULD HAVE TO BE WEIGHED SO A SET PRICE COULD BE GIVEN TO THE COUNCIL TO VOTE ON. BY THE NEXT COUNCIL MEETING WE COULD HAVE THIS INFORMATION.

COUNCILMAN HILL ASKED IF THE CAR COULD BE DONATED.

OLD BUSINESS

MAYOR ADAMS INFORMED COUNCIL THAT THE FEMA ASSESSMENT DOCUMENTS FROM PUBLIC WORKS, THE FIRE DEPARTMENT AND THE POLICE DEPARTMENT HAVE BEEN SUBMITTED TO ED WEBB FROM EMERGENCY MANAGEMENT TODAY.

NEW BUSINESS

MAYOR ADAMS REMINDED COUNCIL THAT BUDGET WORK SESSIONS ARE ON THURSDAY AT 2:00 P.M.; 3:00 P.M.; AND 4:00 P.M. AND ON FRIDAY AT 1:30 P.M. AND 2:30 P.M. AND COUNCIL REQUESTED TO HAVE PAPER COPIES OF THE BUDGET WORK SHEETS. MAYOR ADAMS SAID IN THE MORNING HE WOULD GO TO THE COURT MEETING AND AS YOU KNOW THE INTERLOCAL STARTED ON JULY 1 AS A VERBAL AGREEMENT AND WE JUST NOW GOT IT ON PAPER AND IS ONLY GOOD UNTIL JUNE 30 AND WE WILL BE WITHOUT AN AGREEMENT AGAIN. MAYOR ADAMS WILL PRESENT THE DISPATCH BUDGET TO THE COURT FOR NEXT YEAR AND TRY TO GET THEM TO COMMIT FOR ANOTHER YEAR BECAUSE THEY ONLY COMMIT FOR ONE YEAR AT A TIME.

DEPARTMENT REPORTS:

A. TEEN COUNCIL – SAVANNAH HILL SAID CHRISTIAN ACADEMY HAD A PENNY WAR AND RAISED \$6,000; LAST FRIDAY WAS THE BOYS FINAL BASKETBALL GAME AND HOMECOMING; THE JUNIOR SENIOR TRIP IS IN MAY AND THEY ARE STILL LOOKING FOR WAYS TO RAISE MONEY SO EVERYONE DOES NOT HAVE TO PAY THE FULL \$1,000.

COUNCILMAN GORDON ASKED WHERE THEY WERE GOING.

MS. HILL REPLIED THEY ARE GOING TO FLORIDA TO DO MISSIONARY WORK FOR A WEEK.

MAYOR ADAMS ASKED HOW ANY STUDENTS ARE ENROLLED AT CHRISTIAN ACADEMY.

MS. HILL REPLIED 160 STUDENTS.

MAYOR ADAMS SAID ASHLEY SPENNEBERG WAS AT A SCHOOL PROGARM.

B. PUBLIC WORKS – RON KNIGHT WAS NOT PRESENT, BUT TROY HARELL, ASST. PUBLIC WORKS SUPV., SAID THEY HAVE BEEN WORKING ON FLOOD CLEAN UP AND FILLED IN SOME POTHOLES LAST WEEK.

COUNCILMAN CRAIG INFORMED MR. HARELL THAT THE STREET LIGHTS NEXT TO CAPTAIN HOOK'S RESTAURANT ARE OUT.

MR. HARELL SAID THERE ARE MANY TRANSFORMS THAT ARE BAD AND MR. KNIGHT IS REPLACING THEM WITH LED LIGHTS.

MAYOR ADAMS SAID THAT MR. KNIGHT WAS SWITCHING THE LIGHTS OVER TO LED AND HAS CHANGED SOME HERE AT CITY HALL. MAYOR ADAMS ASKED MR. HARELL ABOUT THE SKATE PARK, THE BASKETBALL COURT, RIVERWALK, AND PARKING LOTS.

MR. HARELL SAID THE MUD HAD BEEN REMOVED FROM THE SKATE PARK AND THE BASKETBALL COURT AND MR. KNIGHT IS ORDERING AN EXTRA BROOM TRUCK AND THEY WILL HAVE TO PRESSURE WASH THE RIVERWALK AND OTHER AREAS.

MAYOR ADAMS SAID IF THEY NEEDED HELP WITH PRESSURE WASHING THAT MIKE TERRELL COULD HELP WITH THE FIRE TRUCK.

MAYOR ADAMS SAID THAT SATURDAY WAS THE COMMUNITY CLEAN UP DAY AT POINT PARK AT 9:00 A.M. AND HIS FOCUS WAS ON THE TOP OF THE BANK, FIELDS, AND RIVERWALK. EVERYONE NEEDS TO MEET AT THE BATHROOMS AT POINT PARK TO BE GIVEN GLOVES AND TRASH BAGS AND TO SPLIT INTO GROUPS.

MS. HILL ASKED IF CHRISTIAN ACADEMY COULD BE INVOLVED IN THE COMMUNITY CLEAN UP DAY.

MAYOR ADAMS SAID ABSOLUTELY AND IF YOU KNOW ANYBODY WHO NEEDS COMMUNITY SERVICE HOURS I WILL SIGN THEIR FORM.

MS. HILL ASKED IF SHE COULD HAVE SOMETHING TO PASS OUT AT SCHOOL REGARDING THE COMMUNITY CLEAN UP DAY.

COUNCILWOMAN FRANKLIN SAID SHE WOULD MAKE FLYERS TO PASS OUT.

MR. TERRELL ASKED IF WE NEEDED ANY MORE GLOVES.

MAYOR ADAMS SAID HE HAS 144 PAIRS OF COTTON GLOVES AND WE COULD USE A FEW RUBBERS GLOVES. MAYOR ADAMS STATED WE ARE ONLY A MONTH AND HALF AWAY FROM OUR FIRST EVENT AT POINT PARK.

COUNCILMAN LOUDEN ASKED IF THE LIGHTS ALONG THE RIVERWALK HAVE BEEN FIXED.

MAYOR ADAMS SAID NO HE WANTS TO WAIT UNTIL THE RIVEWALK IS CLEANED UP BEFORE HE CALLS KU.

MR. SHAW ASKED IF THE COMMUNITY CLEAN UP DAY WAS CANCELED DUE TO THE WEATHER WHAT IT THE RESCHEDULE DATE.

MAYOR ADAMS SAID THE FOLLOWING SATURDAY.

CHAPLAIN, REV. TIM POLLEY, INFORMED COUNCIL THAT THERE WAS A STREET LIGHT OUT AT THE CARROLLTON CHRISTIAN CHURCH.

MAYOR ADAMS SAID HE HAS A LIST OF LIGHTS THAT ARE OUT IN THE CITY AND WILL MAKE SURE THAT THE LIGHT AT THE CARROLLTON CHRISTIAN CHURCH IS INCLUDED ON THE LIST.

- C. UTILITIES BILL OSBORNE, UTILITIES SUPERVISOR, SAID A FEW OF THE FLOOD RESPONSE ISSUES THEY HAD TO DEAL WITH WAS AN 18" PIPE IN GREENS BOTTOM BROKE OVER THE WEEKEND AND CREWS FINALIZED THE REPAIR TODAY; HE HAS SUBMITTED THE FEMA ASSESSMENT DOCUMENTS AND SEVERAL LIFT STATIONS HAVE DAMAGE AND CLEAN UP ISSUES; HAD TWO WATER MAIN BREAKS ON THE WEST SIDE; ABOUT 100 CUSTOMERS WERE WITHOUT GAS AND ALL BUT JUST A FEW ARE BACK ON; THERE WAS AN IMPACTED ON INDUSTRIAL GAS USAGE DUE TO THE ABSENCE OF BARGE TRAFFIC. THE GREENSAND BUILDING IS MOVING ALONG A LITTLE FASTER AND THE TANKS HAVE BEEN SET JUST WORKING ON THE PIPING. CARROLLTON UTILITIES IS FLUSHING THE HYDRANTS THIS WEEK AND NEXT WEEK. THE DOC IS UNDERWAY; THE REBAR SHOULD BE HERE WEDNESDAY AND EXPECT FOR THE FOOTERS TO GET STARTED THEN; AND CARROLLTON UTILITIES IS OPENING BIDS ON CONCRETE MATERIAL ON WEDNESDAY. ONE LAST THING MEETING WITH EDA/GARY THIS WEEK TO SEE ABOUT GETTING GRANT FUNDS TO ADD CAPACITY TO WASTEWATER COLLECTION SYSTEM.
- **D.** CCCDC GARY MATHIS WAS NOT PRESENT.
- E. TOURISM MISTY WHEELER WAS NOT PRESENT.
- F. POLICE DEPARTMENT MIKE WILLHOITE, POLICE CHIEF, ASKED IF ANYONE HAD QUESTIONS ABOUT THE MONTHLY REPORT, SINCE JANUARY, FEBRUARY, AND MARCH ARE SLOWER MONTHS FOR THE POLICE DEPARTMENT SEVERAL OFFICERS ARE COMPLETING TRAINING DURING THIS TIME, AND THERE ARE TWO POLICE CRUISERS IS IN THE SHOP FOR REPAIRS. MR. WILLHOITE ASKED EVERYONE TO LOOK OVER THE YEARLY REPORT AND HE HIGHLIGHTED ON SOME TOPICS. MR. WILLHOITE STATED THAT 2017 WAS THE SECONDED BUSIEST YEAR FOR CALLS; THE DRUG TREND HAS GONE FROM HEROIN TO METHAMPHETAMINES; AND THEY SEIZED \$11,000.

- **G. FIRE DEPARTMENT** MIKE TERRELL, FIRE CHIEF, SAID THEY HAD ZERO RUNS TO 534 MAIN STREET LAST MONTH AND A TOTAL OF 30 RUNS FOR THE MONTHS OF JANUARY AND FEBRUARY. STILL TRYING TO FIX THE LADDER TRUCK HAD A PART INSTALLED BUT DID NOT FIX THE PROBLEM AND HAS ORDER A DIFFERENT PART AND IS STILL LOOKING FOR A DOOR HANDLE FOR THE OLD LADDER TRUCK.
- H. CODE ENFORCEMENT JOHN WELCH SAID THAT P&Z IS STILL TAKING A LOOK AT MANUFACTURED HOUSING AND AT THE LAST P&Z MEETING THEY HAD A GUEST SPEAKER FROM THE KENTUCKY MANUFACTURED HOUSING INSTITUTE WHO FILLED THEM IN ON THE CURRENT STATE OF THESE TYPES OF HOMES AND THE MODEL CODES AND THE MANNER WHICH MANUFACTURED HOUSING AND CITIES HAVE COME TOGETHER AND GIVE THE CITY SOME TYPE OF AUTHORITY ON HOW THESE TYPES OF HOMES ARE PLACED WITHIN THE TOWN. MR. WELCH STATED THAT MANUFACTURED HOUSING IS UNDER THE HUD CODE NOT THE STATE RESIDENTIAL CODE BUT WE CAN WRITE ORDINANCES FOR THIS TYPES OF HOUSES TO MEET CERTAIN CRITERIA.

COUNCILMAN GORDON ASKED MR. WELCH IF HE WAS WORKING ON GETTING AN ORDINANCE TOGETHER.

MR. WELCH REPLIED YES HE WAS LOOKING FOR THE INFORMATION FROM THE KENTUCKY MANUFACTURED HOUSING INSTITUTE AND WAS PREPARING A ROUGH DRAFT. MR. WELCH SAID THAT BISHOP'S TRACE IS MOVING ALONG AND TWO CONDO UNITS HAVE BEEN SOLD WITH THE OWNERS EITHER IN THE PROCESS OF MOVING IN OR HAVE MOVED IN BY THIS MEETING; MR. THOMAS SENT TO US THE RESTRICTIONS FOR THE SUBDIVISION WHICH WERE REVIEWED AND REVISED PER OUR ZONING CODE; MR. THOMAS ALSO INFORMED ME THAT THEY WILL BE PRODUCING A NEW PLAT ENTITLED BISHOPS TRACE DEVELOPMENT. THE NEW PLAT WILL HAVE THE OVERALL DIVISION OF THE PROPERTY INTO THREE SECTIONS, ONE BEING THE SUBDIVISION WITH PROVISIONS FOR SINGLE FAMILY LOTS, DUPLEX AND FOURPLEX CONDO UNIT AND WILL BE REVIEWED BY P&Z. THE BOA MADE THEIR RULING TO DENY THE CONDITIONAL USE PERMIT FOR THE CROWELL'S PROPOSED RV FACILITY AND MADE AN AGREEMENT WITH THE CROWELL'S THEY COULD DO SOME MAINTENANCE TO THE PROPERTY BUT NOTHING TO FURTHER THE RV PARK.

COUNCILMAN GORDON ASKED IF THE STATE WAS GOING TO MAINTAIN THE LIGHT.

MAYOR ADAMS SAID YES, THAT IS MY UNDERSTANDING. MAYOR ADAMS SAID PLEASE TAKE NOTE OF THE COA TWO CONFERENCE IN BOWLING GREEN, KENTUCKY MAY 23, 24, 25 AND IF YOU WOULD LIKE TO ATTEND PLEASE LET ME OR MELINDA KNOW. THE BAD CONFERENCE IS IN LEXINGTON JUNE 27, 28, 29 AND AGAIN IF YOU WOULD LIKE TO ATTEND PLEASE LET ME OR MELINDA KNOW.

MAYOR ADAMS THEN PRESENTED CHAPLAIN, REV. TIM POLLEY WITH THE AMBASSADOR AWARD.
