


**ORDINANCE # 2023-17**  
**AN ORDINANCE SETTING THE 2023 AD VALOREM TAX**  
**RATE FOR THE CITY OF CARROLLTON**

BE IT ORDAINED by the City of Carrollton that Pursuant to KRS 132, the City of Carrollton is hereby setting the 2023 *Ad valorem* Tax Rate.


1. Section One: There is hereby levied an ad valorem tax of \$ 0.289 on each One Hundred Dollars (\$100.00) of assessed valuation on all real property subject to taxation in the City of Carrollton, Carroll County, Kentucky, for the year 2023: and an ad valorem tax of \$ 0.301 on each One Hundred Dollars (\$100.00) of assessed valuation on all personal tangible property in the City of Carrollton, Carroll County, Kentucky, for the year 2023: and an ad valorem tax of \$ 0.26 per \$100.00 of assessed valuation of motor vehicle and watercraft in the City of Carrollton, Carroll County, Kentucky, for the year 2023.
2. Section Two: The tax levied by this Ordinance shall be paid to and collected by the City Treasurer of the City of Carrollton, Kentucky.
3. Section Three: The tax levied by this Ordinance when collected shall be applied to the following purposes: One Hundred Percent (100%) to the payment of the current expenses and lawful obligations of the City of Carrollton, Carroll County, Kentucky, not otherwise provided for.
4. Section Four: The tax levied by this Ordinance shall be due and payable on the adoption, approval and publication of this Ordinance, and, if unpaid by December 1, 2023, shall be considered delinquent as of that date and so endorsed.
5. Section Five: Any tax levied by this Ordinance which becomes delinquent by reason of nonpayment shall be subject to the penalty of 10% of the amount of such taxes unpaid before December 1, 2023, which penalty shall be added to such taxes which are unpaid on December 1, 2023, and which penalty shall be collectible as part of such taxes on and after December 1, 2023. Delinquent taxes penalties thereon are applicable at the time of payment and shall bear interest at the rate of 12% per year from December 1, 2023, until paid, which interest shall be likewise collectible as part of such taxes.
6. Section Six: The notice required to be published by KRS 92.580 shall be published prior to collection.

After a reading in full on the 22<sup>nd</sup> day of September, 2023, followed by a second reading in full on the 25<sup>th</sup> day of September, 2023, and on motion by Councilman Booth seconded by Councilwoman Davis, the ordinance was adopted by a vote of 6 ayes and 0 nays.
