SPLASH PARK

MAYOR ADAMS SAID DENNIS HAWKINS HAS BEEN SUBCONTRACTED TO DO THE PLUMPING WORK AT THE SPLASH PARK. DWA RECREATION, INC RECOMMENDED NOT TO OPEN THE SPLASH PARK NEXT YEAR DUE TO THE FACT WE ARE SO CLOSE TO WINTER.
