CALL TO ORDER

THE MEETING WAS CALLED TO ORDER AT THE HOUR OF 7:02 P.M. BY MAYOR ADAMS. MAYOR ADAMS LED THE PLEDGE OF ALLEGIANCE. COUNCILMAN LOUDEN OFFERED THE INVOCATION.

RECOGNITION OF GUESTS

THOMAS & CONNIE EVENS

MR. EVENS FORMALLY INTRODUCED HIMSELF AS THE REPUBLICAN CANDIDATE FOR JAILER IN THE NOVEMBER ELECTION. IF ELECTED, HE WOULD LIKE TO HAVE AN ADDITION BUILT ON SO INMATES AREN'T SLEEPING ON THE FLOOR. HE WOULD ALSO LIKE TO INCREASE INMATE PROGRAMS AT THE JAIL.

SATOLLI GLASSMEYER

MR. GLASSMEYER GAVE AN OVERVIEW OF HIS COMPANY, HISTORY IN YOUR OWN BACKYARD. HE HAS DONE DOCUMENTARY WORK IN KENTUCKY, INDIANA, AND OHIO. HE CURRENTLY HAS PLANS TO DO FILMING IN CARROLL COUNTY OF THE MASTERSON HOUSE FOR THE HISTORICAL SOCIETY.

HE SHARED A SEGMENT OF A SHORT DOCUMENTARY THAT HIS COMPANY HAS COMPLETED. IF THE CITY IS INTERESTED, HE WOULD HAVE AN INTERVIEWER COME AND TALK TO ONE PERSON FOR ABOUT THIRTY MINUTES. IT TAKES TWO TO THREE WEEKS TO PRODUCE AND EDIT THE VIDEO, WHICH CAN BE 3 TO 15 MINUTES IN LENGTH. THE COMPLETED VIDEO WILL BE ON HIS WEBSITE, YOU TUBE CHANNELS, AND GOOGLE MAPS. HE ALSO SENDS A COPY TO THE STATE LIBRARY IN FRANKFORT. LINKS TO THE VIDEO ARE ALSO SENT TO SCHOOLS AND OTHER COMMUNITIES IN THE AREA. THE VIDEO COULD ALSO BE PUT ON THE CITY'S WEBSITE.

TYPICALLY, THE COST IS \$1,799. HE HAS AN ANONYMOUS CO-SPONSOR COVERING THE FIRST \$1,000 FOR 10 VIDEOS IN THE AREA. THE CITY'S COST WOULD BE \$799.

COUNCILMAN CRAIG SAID TOURISM WOULD PROBABLY PAY HALF, SO THE CITY WOULD ONLY HAVE TO PAY AROUND \$400. MAYOR ADAMS SAID HE THOUGHT IT WOULD BE A GOOD MARKETING TOOL. HE TOLD MR. GLASSMEYER THAT THE CITY WOULD BE IN TOUCH WITH HIM AFTER JULY 1, THE NEW BUDGET YEAR.

CODE ENFORCEMENT BOARD RECOMMENDATIONS

PROPERTY AT 704 11TH STREET WAS FIRST CITED JANUARY 31, 2018 FOR UNFIT CONDITIONS. THE PROPERTY'S LAST INSPECTION ON APRIL 4, 2018 SHOWED REPAIRS HAD NOT BEEN MADE TO MEET COMPLIANCE. IT IS THE BOARD'S RECOMMENDATION TO ABATE FOR DEMOLITION OF 704 11TH ST.

PROPERTY AT 901 6TH ST WAS CITED FOR OVERGROWN GRASS AND WEEDS, RUBBISH, TIRES, SCRAP METAL AND UNFIT CONDITIONS OF THE HOUSE EXTERIOR. THE GRASS HAS BEEN MOWED. THE MATTERS WITH RUBBISH, TIRES, SCRAP METAL AND THE UNFIT CONDITIONS OF THE HOUSE EXTERIOR HAVE NOT BEEN ADDRESSED.

MAYOR'S REPORT

SPLASH PARK

MAYOR ADAMS INFORMED COUNCIL THERE IS AN ISSUE WITH THE STATE. THE STATE HAS TO DO A PLUMBING INSPECTION OF THE SPLASH PARK. JUSTIN PITTMAN, OF THREE RIVERS DISTRICT HEALTH DEPARTMENT, WAS IN THE OFFICE TODAY AND MADE PHONE CALLS TO ASSIST THE CITY. THE STATE SAYS WE MUST SUBMIT DETAILED DRAWINGS WITH EITHER AN ARCHITECT OR ENGINEER TO SIGN OFF ON THE PLANS. THERE IS NO ENGINEER OR ARCHITECT ON THIS JOB. MAYOR ADAMS CALLED CHRIS AT DWA AND EXPLAINED THE SITUATION. HE SAID WHATEVER IT COSTS, THEY WILL COVER. CHRIS CALLED AN ASSOCIATE. HE WILL PUT THE PLANS ON PAPER FOR \$4,400. IT WILL BE \$6,000 TO HAVE THE PLANS ON PAPER AND FOR HIM TO SIGN OFF ON THE PLANS. THE MAYOR IS GOING TO TALK TO CARROLLTON UTILITIES TO SEE IF ONE OF THEIR ENGINEERS COULD DRAW THE PLANS AND SIGN OFF ON THEM SINCE IT WOULD BE THEIR DOCUMENT.

THE VOLLEYBALL COURT AT POINT PARK HAS BEEN RELOCATED. IF ANOTHER ONE IS NEEDED, PUBLIC WORKS CAN DO IT. COUNCILMAN CRAIG SUGGESTED LIGHTS FOR THE VOLLEYBALL COURT. MAYOR ADAMS SAID CAMERAS ARE ALSO NEEDED DOWN AT THE PARK. A MESS WAS MADE ON ONE OF THE SLIDES OVER THE WEEKEND. TWO LILAC TREES HAVE BEEN STOLEN DOWN AT POINT PARK. COUNCILMAN CRAIG SAID MORE PATROL IS NEEDED.
