# <u>DISCUSSION / CONSIDER / APPROVE ON DESIGN REVIEW BOARD</u> <u>RECOMMENDATION OF EIP 50-50 MATCHING FUNDS / SIGNAGE FOR THE LEMON</u> <u>DROP BOUTIQUE</u>

ROBERT HOFMANN TOLD COUNCIL HE HAD A RECOMMENDATION FROM DRB ON THE APPLICATION SUBMITTED BY DEIDRA HAYS FOR THE E.I.P. 50/50 MATCHING GRANT FOR SIGNAGE AT HER NEW BUSINESS, THE LEMON DROP BOUTIQUE, AT 410 MAIN STREET. TOTAL SIGN COST IS \$430.00. SHE IS WORKING WITH A LOCAL BUSINESS, 732 HERE'S YOUR SIGN. TOTAL REIMBURSEMENT AMOUNT WOULD BE \$215.00.

# <u>DISCUSSION/CONSIDER APPROVE OF THE RENT ASSISTANCE APPLICATION</u> FROM THE LEMON DROP BOUTIQUE.

SAM BURGESS TOLD COUNCIL THAT THE CARROLLTON MAIN STREET PROGRAM'S ECONOMIC VITALITY COMMITTEE REVIEWED THE APPLICATION OF DEIDRA HAYS FOR THE RENT SUBSIDY PROGRAM FOR HER BUSINESS, THE LEMON DROP BOUTIQUE. HE SAID THE COMMITTEE HAD SOME CONCERNS, BUT DO RECOMMEND THE \$500/MONTH GRANTABLE AMOUNT. ONE CONCERN WAS, WHAT FOLLOW-UP WILL THERE BE TO ENSURE COMPLIANCE WITH THE ORDINANCE? THE OTHER CONCERN WAS WHO WOULD BE RESPONSIBLE FOR THE FOLLOW-UP? DEIDRA WILL MEET QUARTERLY WITH HER MENTOR, CHARLOTTE WALLACE. IT WAS ALSO DISCUSSED THAT THE SMALL BUSINESS ADMINISTRATION COULD ALSO ASSIST DEIDRA. MAYOR ADAMS SAID MR. BURGESS OR HER MENTOR, CHARLOTTE WALLACE, COULD GIVE AN UPDATE TO THE MAYOR OR ROBERT HOFMANN. MR. BURGESS SAID THEY NEED CLARIFICATION ON WHAT FOLLOW-UP IS NEEDED. MAYOR ADAMS SAID THE RENT ASSISTANCE WILL BEGIN SEPTEMBER 1.

THE MOTION WAS MADE BY COUNCILWOMAN FRANKLIN AND SECONDED BY COUNCILMAN DICKOW AND DULY CARRIED TO ACCEPT THE ECONOMIC VITALITY COMMITTEE'S RECOMMENDATION FOR LEMON DROP BOUTIQUE TO RECEIVE 100% FUNDING FOR THE RENT SUPPORT PROGRAM, WHICH WILL BE \$500/MONTH FOR ONE YEAR.

#### **UNFINISHED BUSINESS**

MAYOR ADAMS SAID MR. THOMPSON SENT OUT AN EMAIL TODAY TO COUNCIL THAT INCLUDED A DRAFT REVISION FOR THE HISTORIC DISTRICT ORDINANCE.

MAYOR ADAMS SHARED SOME INFORMATION ON PLAYGROUND EQUIPMENT. HE CAN GET THE SPECS ON THE DIFFERENT EQUIPMENT SO IT CAN ALL GO TO BID.

MAYOR ADAMS SAID IT WAS MENTIONED AT FRIDAY'S SPECIAL MEETING FOR COUNCIL TO CONSIDER GIVING CITY EMPLOYEES SOME AMOUNT OF DAYS IF THEY TEST POSITIVE FOR COVID OR HAVE TO BE QUARANTINED. THE FEDERAL GOVERNMENT MANDATED LAST YEAR THAT EACH EMPLOYEE BE ALLOWED UP TO 80 HOURS. THAT MANDATE ENDED MARCH 31, 2021. COUNCILMAN DICKOW SAID THE MAYOR LEFT OUT ABOUT THAT THE EMPLOYEES WOULD ONLY BE ENTITLED TO THE PAY IF THEY WERE VACCINATED. HE IS AGAINST GIVING THE PAY TO ONLY VACCINATED EMPLOYEES. COUNCILMAN LOUDEN SAID HE IS NOT IN FAVOR OF SPECIAL PAY. EMPLOYEES RECEIVE 12 SICK DAYS PER YEAR, IN ADDITION TO VACATION AND HOLIDAY TIME. HE ALSO SAID UNLESS THE FEDERAL GOVERNMENT TELLS US WE HAVE TO PAY, WE NEED TO LEAVE EVERYTHING ALONE.

#### **NEW BUSINESS**

MAYOR ADAMS SAID THE BID ADVERTISEMENT FOR THE SALT BIN SHOULD BE IN THE SEPTEMBER  $2^{\rm ND}$  PAPER. PRE-BID MEETING WILL BE SEPTEMBER  $7^{\rm TH}$ . BIDS WILL BE DUE AT 4:00 P.M. ON SEPTEMBER  $13^{\rm TH}$ .
