ATTORNEY FOR THE CITY, AMY EVERSOLE, OPENED AND READ THE ONLY BID BY RON KNIGHT IN THE AMOUNT OF \$480 PER YEAR. HE ALSO SUBMITTED THAT HE KNEW HE HAD TO CARRY LIABILITY INSURANCE OF \$500,000 PER YEAR.

# **DEPARTMENT REPORTS:**

- A. TEEN COUNCIL JENAH ROBERTS SAID SPRING BREAK IS THE 1<sup>ST</sup> WEEK OF APRIL.
- **B. PUBLIC WORKS** RON KNIGHT, PUBLIC WORKS SUPERVISOR, SAID THEY HAVE BEEN PLACING GRAVEL ALONG THE SIDES OF CITY STREETS AND IN ALLEYS. MOST OF THE WORK ON THE ROAD GOING TO THE NEW PROPERTY IS COMPLETE. REPAIRS HAVE BEEN MADE TO THE OLD SWEEPER TRUCK AND IT IS RUNNING.
- C. UTILITIES BILL OSBORNE, UTILITIES SUPERVISOR, SAID THAT FEB. 10<sup>TH</sup> SET A RECORD FOR GAS USAGE. THEY HAVE BEEN DEMOLISHING THE OLD WASTEWATER TREATMENT PLANT. HE ALSO REPORTED THAT THE NORTHERN KY. JOINT HEALTH INSURANCE HAD VOTED TO ONLY INCREASE PREMIUMS 7% NEXT FISCAL YEAR AND IS CONSIDERING ANOTHER OPTION IN HEALTH INSURANCE PLANS FOR EMPLOYEES.
- **D.** CCCDC GARY MATHIS, CCCDC EXECUTIVE DIRECTOR, GAVE UPDATES ON 3 GRANTS HE IS WORKING ON. HE IS AWAITING FINAL APPROVAL ON THE CARROLLTON RIVERWALK GRANT FROM THE FEDERAL TRAILS GROUP. THE OTHER TWO GRANTS FOR THE BOW BRIDGE AND THE OTHER PORTION OF THE RIVERWALK MAY BE AFTER SEPTEMBER BEFORE FINAL APPROVAL. THE HIGHWAY SAFETY GRANT HAS BEEN SUBMITTED FOR \$19,555. THERE WAS POSITIVE REACTION TO IT FOR THE PURCHASE OF TWO RADAR GUNS AND OTHER ITEMS FOR THE POLICE DEPT.

- **E. TOURISM** MISTY WHEELER, TOURISM DIRECTOR, SAID THE TBF NATIONAL SEMI-FINAL BASS TOURNAMENT WILL BE AT POINT PARK THIS YEAR ON OCT. 15 & 16. THE KY. RIVER PADDLE RACE HAS BEEN CHANGED TO JUNE 25<sup>TH</sup> NOT THE 24<sup>TH</sup>. THE CIVAL WAR DAYS WILL BE ON APRIL 15<sup>TH</sup> FOR SCHOOL CHILDREN, AND APRIL 16<sup>TH</sup> & 17<sup>TH</sup>.
- **F. POLICE DEPARTMENT** TIM MITCHELL, ASSISTANT POLICE CHIEF, SAID THEY SHOULD BE FULLY STAFFED BY NEXT MEETING AFTER JENNIFER CROWELL'S RESIGNATION.
- **G. FIRE DEPARTMENT** MIKE TERRELL, FIRE CHIEF, SAID A LETTER OF CERTIFICATION HAD BEEN RECEIVED FOR THE LADDER TRUCK AFTER COMPLETION OF REPAIRS. FOUR MEMBERS OF THE FIRE DEPARTMENT HAD ATTENDED TRAINING.
- H. CODE ENFORCEMENT JOHN WELCH SAID HE IS WORKING ON THE RENTAL PROPERTY ORDINANCE AND IT WILL NEED TO BE REVIEWED BY AMY EVERSOLE BEFORE PRESENTING TO COUNCIL. HE SAID THEY WOULD HAVE A NEW MEMBER TO RECOMMEND FOR DRB AT THE NEXT MEETING. THE MAYOR RECOMMENDED THAT THE OTHER TWO TENANTS AT THE PROPERTY AT SIXTH STREET BE REMOVED ALSO. COUNCIL AGREED AND MR. WELCH SAID HE WOULD MOVE FORWARD WITH THAT.
- I. CLERK –TREASURER LEATHA GRIMES REMINDED COUNCIL OF BUDGET MEETINGS THIS WEEK, 3/16 & 3/17 STARTING AT 1:30. SHE ALSO ASKED THEM TO BE SURE AND BRING THEIR WORKSHEETS WITH THEM THAT THEY RECEIVED IN THEIR PACKETS.
- J. MAIN STREET SAM BURGESS, MAIN STREET DIRECTOR, GAVE A WAYFINDING SIGNAGE UPDATE. HE SAID HE HAD MET WITH FOUR DIFFERENT PEOPLE WITH THE STATE HIGHWAY DEPT. FROM DISTRICT 6 AND STILL HAD NO ANSWERS TO BASIC QUESTIONS. HE HAD RECEIVED NOTIFICATION THAT CARROLLTON MAIN STREET IS ONCE AGAIN ACCREDITED. EASTER ON THE SQUARE WILL BE SATURDAY, 3/26 AT NOON.
