CALL TO ORDER:

THE MEETING WAS CALLED TO ORDER AT THE HOUR OF 7:05 P.M. BY MAYOR ADAMS. MAYOR ADAMS LED THE PLEDGE OF ALLEGIANCE. CHAPLAIN TIM POLLEY OFFERED THE INVOCATION.

RECOGNITION OF GUESTS:

JENNIFER BEACH CAROLYN JONES LARRY WILLHOITE PASTY STEWART

MAYOR ADAMS WELCOMED CAROLYN JONES AND ASKED MS. JONES IF SHE WOULD LIKE TO ADDRESS THE COUNCIL.

MS. JONES SAID SHE LIVES AT 617 HAWKINS STREET AND WOULD LIKE TO THANK THE CITY FOR FIXING THE STORM DRAIN BESIDE HER HOUSE AND AFTER THE FIRST

HEAVY RAIN THE DRAIN DID HELP. MS. JONES IS HERE TONIGHT TO ADDRESS THE COUNCIL ABOUT THE CHILDREN WHO ARE RIDING RAZORS, MOTORIZED SCOOTERS THAT ARE FAST MOVING, ON THE SIDEWALK AND STREET IN FRONT OF HER HOUSE. MS. JONES ASKED THE COUNCIL WHO IS RESPONSIBLE FOR THE DAMAGES IF HER VEHICLE WOULD BE STRUCK BY ONE OF THESE RAZORS AND IF THERE IS AN ORDINANCE IN PLACE TO ADDRESS THIS ISSUE. MS. JONES STATED SHE HAS TO PARK ON THE STREET DUE TO THE FACT SHE HAS NO DRIVEWAY AND THAT IN THE LAST 15 MONTHS SHE HAS HAD OVER \$26,000 IN DAMAGES FROM HER VEHICLES BEING HIT.

TIM MITCHELL, ASSIST POLICE CHIEF, SAID THERE IS AN ORDINANCE THAT PROHIBITS ANYTHING FROM BEING RIDDEN ON THE SIDEWALKS EVEN BICYCLES BUT AT THIS TIME THERE IS NO ORDINANCE PROHIBITING CHILDREN FROM RIDING THEIR BICYCLES, RAZORS, OR TOYS IN THE STREET.

JAKE THOMPSON, CITY ATTORNEY, SAID THE PERSON RIDING THE RAZOR WOULD BE RESPONSIBLE FOR ANY DAMAGES EVEN THOU THEY WOULD NOT HAVE ANY INSURANCE AND HE WOULD TAKE A LOOK AT THE ORDINANCE.

MAYOR ADAMS TOLD MS. JONES TO CALL THE POLICE IMMEDIATELY AND IF THEY WERE NOT TIED UP THEY WOULD BE THERE TO ADDRESS THE PROBLEM. MAYOR ADAMS SAID THERE IS AN ORDINANCE PERMITTING GOLF CARTS AND SIDE BY SIDE VEHICLES TO BE RIDDEN WITHIN THE CITY LIMITS WITH PROOF OF INSURANCE AND ARE TO BE DRIVEN UNDER 25 MPH. MAYOR ADAMS ASKED MS. JONES WHAT TIME OF THE DAY DOES MOST OF THE DAMAGE OCCUR.

MS. JONES REPLIED IN THE AFTERNOON COMING HOME FROM WORK.

MAYOR ADAMS ASKED LARRY WILLHOITE IF HE WOULD LIKE TO ADDRESS THE COUNCIL.

MR. WILLHOITE ASKED THE COUNCIL IF A MILES PER HOUR SIGN COULD BE INSTALLED BETWEEN 6TH AND 7TH STREET TO HELP WITH SPEEDING AND A SIGN WITH A SILHOUETTE OF A CHILD.

MAYOR ADAMS SAID A SIGN WITH A CHILD AT PLAY IS INTERPRETED TO ALLOW CHILDREN TO PLAY IN THE STREET AND AT THE PUBLIC WORKS TRAINING PROGRAMS THEY RECOMMEND NOT TO INSTALL THESE TYPES OF SIGNS.

MR. WILLHOITE SAID HE DID NOT WANT A CHILD AT PLAY SIGN JUST A SIGN OF A SILHOUETTE OF A CHILD.

MAYOR ADAMS SAID HE WOULD LOOK INTO THE SIGNS.

OLD BUSINESS

MAYOR ADAMS SAID THE SPLASH PARK HAS BEEN ORDERED AND THE LAST THING TO BE FINALIZE IS PICKING THE COLORS OF THE WATER FEATURES AND HE IS STAYING AWAY FROM REDS AND YELLOWS DUE TO THE FACT THESE COLORS WILL FADE OVER TIME. ONCE THE COLORS ARE CHOSEN IT WILL TAKE 6 TO 8 WEEKS FOR DELIVERY GIVING TIME FOR THE WASTE WATER SYSTEM TO BE INSTALLED AND THE PUMP HOUSE TO BE CONSTRUCTED. MAYOR ADAMS SAID THERE ARE STILL PROBLEMS WITH THE RIVERWALK REGARDING THE SLOPS AND ASPHALT. THE RIVERWALK WILL BE RE-ASPHALTED ON JUNE 17 AND STARTING THAT NIGHT THE PAVING JOB FROM DONNA DRIVE IN PRESTONVILLE TO THE INTERSECTION OF HIGHALND AVE AND HIGHWAY 227 WILL BEGAN. MAYOR ADAMS SAID HE WOULD ASK THE ASPHALT COMPANY TO REPAVE AROUND THE STORM DRAIN ON 6TH AND SEMINARY AND ON HAWKINS STREET NEAR MS. JONES HOUSE.

NEW BUSINESS

MAYOR ADAMS STATED THAT RONNIE KNIGHT, PUBLIC WORKS SUPERVISOR, GARY MATHIS, CCCDC, AND HIMSELF ARE WORKING ON THE PLAQUE AND RIBBON CUTTING CEREMONY OF THE BOW BRIDGE FOR THE END OF JULY. A DRAFT OF THE PLAQUE IS BEING PASSED AROUND FOR REVIEW TO PREVENT WHAT HAPPENED WITH THE CHARLIE CARPENTER PLAQUE OF MISSPELLED WORDS. DOW CORNING HAS ALREADY PAID FOR THE PLAQUE IN THE AMOUNT OF \$2,300.

MAYOR ADAMS ASKED THE COUNCIL IF THEY WOULD BE AVAILABLE FOR A SPECIAL MEETING ON THURSDAY, JUNE 14TH AROUND 4:16 P.M. TO AWARD THE EQUIPMENT AND INSTALLATION BID OF THE SPLASHPARK WASTE WATER SYSTEM AND THE SPECIAL MEETING WAS SET.

DEPARTMENT REPORTS:

- **A. TEEN COUNCIL** ASHLEY SPENNEBERG AND SAVANNAH HILL WERE NOT PRESENT.
- **B. PUBLIC WORKS** RON KNIGHT, PUBLIC WORKS SUPERVISOR, HAD NOTHING TO REPORT ONLY THAT HIS DEPARTMENT HAD A LOT TO BE DONE.

MAYOR ADAMS REPORTED THAT THE BOAT DOCK HAD BEEN INSTALLED AND THE LIGHT IS UP ON HIGHLAND AVE.

- C. UTILITIES BILL OSBORNE, UTILITIES SUPERVISOR, SAID THE SEWER RATE INCREASE IS AN AVERAGE OF \$0.53 PER MONTH FOR AN IN-TOWN CUSTOMER; THE CONCRETE FOR THE DOC HAS BEEN COMPLETED AND THE STEEL SHOULD BE FINISHED IN TWO WEEKS; THE NAS NEW METER PROJECT IS PROGRESSING RIGHT ALONG AND THE METER/REGULATOR STATION IS ALMOST DONE AND STARTED WORKING ON THE NEW SERVICE LINE; SHOULD BEGIN WORKING ON THE PMC PROJECT EARLY JULY; CONTINUING TO WORK ON THE NUCOR SEWER PROJECT AND RECEIVED WORD LAST WEEK THAT ARCHEOLOGICAL EVALUATION WILL NOT BE REQUIRED.
- **D. CCCDC** GARY MATHIS SAID LAST MONTH HE PRESENTED TO COUNCIL A GRANT FOR REMOTE ACCESS TO CONNECT WITH THE AT&T HOST SERVICE FOR THE 911 CENTER . HE HAS FOUND A DIFFERENT COMPANY, IN DIGITAL, TO GO WITH THAT WILL SAVE THE CITY \$300-\$400 PER MONTH. ALSO THE \$20,000 MATCH FOR THE PROJECT WOULD DECREES TO \$18,000. MR. MATHIS STATED THE MAIN STREET SURVEY HAS BEEN EXTENDED FOR ANOTHER MONTH. SO FAR ONLY 88 PEOPLE HAVE TAKEN THE SURVEY.
- **E. TOURISM** MISTY WHEELER, TOURISM DIRECTOR, REPORTED SHE HAD BAD NEWS, WITH THE RIVER BEING UP THE INDIANA BASS NATION STATE TOURNAMENT MAY CANCEL THEIR EVENT THIS WEEKEND; THE BILLBOARD ON HIGHWAY 227 HAS

BEEN COMPLETED; THE KR 255 HAS ALSO BEEN CANCELED DUE TO THE FACT NOT ENOUGH PEOPLE REGISTER FOR THE EVENT; THE TOURISM DEPARTMENT WILL START TAKING VIDEO OF THE EVENTS BEING HELD IN CARROLLTON; THE KENTUCKY STATE FAIR THIS YEAR IS AUGUST 16 TO AUGUST 26.

- F. POLICE DEPARTMENT MIKE WILLHOITE, POLICE CHIEF, WAS NOT PRESENT. TIM MITCHELL, ASST. POLICE CHIEF, REPORTED THE POLICE DEPARTMENT COMPLETED THE FIRST PART OF THE HIGHWAY SAFETY CLICK OR TICKET OVER THE MEMORIAL DAY WEEKEND; NICK ABBOTT WAS INJURED AT TRAINING AND IS WORKING AT THE CAMPGROUND UNTIL HE IS CLEARED TO GO BACK TO THE ACADEMY; LAST WEEK THE SCHOOLS HELD AND ACTIVE SHOOTING TRAINING WITH THE STATE POLICE; AFTER MR. MITCHELL AND MR. WILLHOITE COMPLETE MORE ACTIVE SHOOTING TRAINING THEY WILL BE OFFERING PROGRAMS TO THE COMMUNITY; TO RAISE MONEY FOR SHOP WITH A COP THIS YEAR THE POLICE DEPARTMENT IS HAVING A BASKETBALL TOURNAMENT.
- G. FIRE DEPARTMENT MIKE TERRELL, FIRE CHIEF, SAID THEY ONLY HAD ONE RUN TO 534 MAIN, THERE WAS NO FIRE BUT CLOSE THIS TIME. A RESIDENT WAS COOKING WITH A COPPER PLATE AND DID NOT REMOVE THE PLASTIC FILM; THE FIRE DEPARTMENT RAISED \$10,549.35 FOR CRUSADE FOR CHILDREN WITH ROAD BLOCKS, GOLF SCRAMBLES, AND THE CRAVE MOBILE.
- H. **CODE ENFORCEMENT** JOHN WELCH SAID THE CODE ENFORCEMENT BOARD HAS SEVERAL RECOMMENDATIONS FROM TODAY'S MEETING TO ABATE PROPERTIES WITHIN THE CITY.
