CALL TO ORDER:

THE MEETING WAS CALLED TO ORDER AT THE HOUR OF 7:02 P.M. BY MAYOR ADAMS. COUNCILMAN LOUDEN OFFERED THE INVOCATION. MAYOR ADAMS LED THE PLEDGE OF ALLEGIANCE.

MAYOR ADAMS SAID MR. FREEMIN WOULD LIKE TO ADDRESS COUNCIL ABOUT THE PROPERTY LOCATED AT 516 CLAY STREET, CARROLLTON, KENTUCKY. SAID PROPERTY HAS BEEN ABATED BY THE CITY FOR DEMOLITION AND THE CITY IS WAITING ON A COURT ORDER TO START DESTRUCTION. SPAY AND NEUTER FUND

MAYOR ADAMS SAID THE CITY HAS RECEIVED ANOTHER INVOICE FROM CARROLL COUNTY FISCAL COURT FOR CONTRACT LABOR OF DEBBIE SKIRVIN IN THE AMOUNT OF \$2,700 ASKING THE CITY TO PAY FOR HALF (\$1,350). THE FUNDS ALLOCATED FOR SPAY AND NEUTER FUND UP TO \$4,000 WAS BUDGETED IN FY 19-20. SINCE NONE OF THE FUNDS WERE USED IN FY 19-20 THE \$4,000 WAS CARRIED OVER INTO FY 20-21 BUDGET. ONLY \$1,800 WAS SPENT AND REMAINING \$2,200 WAS NOT CARRIED INTO FY 21-22 BUDGET. MAYOR ADAMS BELIEVES THE CITY SHOULD ONLY PAY FOR HALF OF THE COST OF THE VETERINARIAN STATEMENT NOT CONTRACT LABOR OF DEBBIE SKIRVIN. COUNCILMAN LOUDEN SAID PER KRS THE COUNTY IS OBLIGATED TO PROVIDE ANIMAL CONTROL. THERE WAS SOME DISCUSSION.
