## **OLD BUSINESS**

## HISTORY IN YOUR OWN BACKYARD

MAYOR ADAMS TOLD COUNCIL THAT THE TOURISM COMMISSION HAS OPTED OUT OF PAYING HALF FOR THE VIDEO TO BE PRODUCED. HE ALSO PROVIDED COUNCIL WITH ANSWERS TO QUESTIONS THEY HAD FROM THE PREVIOUS MEETING. THE COMPANY OWNS THE RIGHTS TO THE VIDEO. THE CITY CAN EDIT AND TAKE ANYTHING OUT THAT WOULD HAVE A NEGATIVE EFFECT ON THE CITY. THERE ARE GOING TO BE SEPARATE VIDEOS OF THE BUTLER MANSION & THE MASTERSON HOUSE. SEGMENTS FROM THEM COULD BE PART OF THE CITY'S VIDEO. IF THE CITY COMMITS IN JULY, THE COST WOULD BE \$795. COUNCIL DECIDED TO NOT MOVE FORWARD AT THIS TIME WITH THE VIDEO. MAYOR ADAMS WILL CONTACT MR. GLASSMEYER AND LET HIM KNOW COUNCIL'S DECISION. COUNCILMAN GORDON SAID A NICE VIDEO WAS MADE ON THE BOW BRIDGE. HE SUGGESTED CONTACTING THAT GENTLEMAN, AS WE KNOW THE QUALITY OF HIS WORK.

### **NEW BUSINESS**

### **PRECISION CONCRETE CUTTING**

MAYOR ADAMS REVIEWED THE PROPOSAL FROM PRECISION CONCRETE CUTTING TO REPAIR TRIP HAZARDS ALONG CITY SIDEWALKS ON FOURTH STREET, FIFTH STREET, AND SIXTH STREET, FROM HIGHLAND AVENUE TO PARTS OF SYCAMORE AND SEMINARY STREETS. THEY WILL GRIND 1/2" TO 2" THAT ARE REPAIRABLE. THE ORIGINAL COST IS \$6,495. THERE IS A \$500 SAVINGS BEING A REPEAT CLIENT AND IF THE CITY MAKES THE COMMITMENT IN JULY. MAYOR ADAMS BELIEVES THE \$5,995 WILL DROP TO \$4,000 - \$4,500, IF NOT LOWER, SINCE SOME OF THE SIDEWALKS HAVE ALREADY BEEN REPAIRED OR ON THE LIST TO REPAIR THIS YEAR.

## **SIDEWALKS**

## HIGHLAND AVENUE PROJECT

THE CAVITY IS STILL UNDER THE ROAD IN FRONT OF NAPA. MAYOR ADAMS SAID THERE ARE SEVERAL CAVITIES ALONG HIGHLAND AVENUE. THERE IS NO BASE ON HIGHLAND. THIS IS A STATE PROBLEM, NOT AT&T'S. THE WORK SHOULD BE COMPLETED TOWARDS THE END OF THE WEEK.

### "WELCOME TO CARROLLTON" SIGNS

THE CITY HAS APPLIED FOR AND RECEIVED ENCROACHMENT PERMITS TO REINSTALL THE "WELCOME TO CARROLLTON" SIGNS. GARY TILLEY IS GOING TO GIVE AN ESTIMATE OF PAINTING THE SIGNS. THE MAYOR ASKED COUNCIL TO TAKE A LOOK AT THE SIGNS AND OFFER SUGGESTIONS ON THE COLORS. HE SUGGESTED THE FRONT OF LETTERS BE BLACK. THE SIGN COULD BE WHITE AND THE TRIM COULD BE THE BLUE THAT IS IN OUR LOGO.

### **GRANT MONEY**

ALL MONEY EXCEPT \$5,000 HAS BEEN RECEIVED FOR BOTH OF THE GRANTS. THE STATE IS HOLDING THE \$5,000 FOR THE HANDRAIL. PUBLIC WORKS CAN BUILD A HANDRAIL FOR LESS THAN WHAT ONE COULD BE PURCHASED FOR. THE KENTUCKY RIVER SIDE ALSO NEEDS THREE LIGHTS INSTALLED.
