UNFINISHED BUSINESS

THERE WAS NO UNFINISHED BUSINESS.

NEW BUSINESS

MAYOR ADAMS SAID OFFICER RON DICKOW COMPILED A LIST OF STREET LIGHTS THAT ARE OUT. KENTUCKY UTILITIES WILL REPAIR. OFFICER DICKOW ALSO MADE SOME RECOMMENDATIONS FOR NEW LIGHTS NEEDED WITHIN THE CITY LIMITS. ONE RECOMMENDATION WAS ON HWY 36, THE ENTRANCE TO CHRISTIAN ACADEMY. THE STATE ONLY INSTALLS LIGHTS AT INTERCHANGES. THEREFORE, IT WOULD BE AT THE CITY'S EXPENSE TO INSTALL A LIGHT AT THE ENTRANCE TO CHRISTIAN ACADEMY.

MAYOR ADAMS SAID THE 71 INTERCHANGE WAS WITHOUT LIGHTS THIS PAST WEEKEND. THE STATE IS COMING DOWN WEDNESDAY TO REVIEW WHAT CAUSED THE OUTAGE.

PLANNING & ZONING COMMISSION HAS A RECOMMENDATION TO CITY COUNCIL THAT THE ZONING MAP AMENDMENT FOR PVA PARCEL ID 22-17 HIGHLAND AVENUE FROM WHAYNE SUPPLY BE DENIED.

THE MOTION WAS MADE BY COUNCILMAN GORDON AND SECONDED BY COUNCILMAN LOUDEN AND DULY CARRIED TO ACCEPT PLANNING & ZONING COMMISSION'S RECOMMENDATION TO DENY THE ZONING MAP AMENDMENT FOR PVA PARCEL ID 22-17 HIGHLAND AVENUE FROM WHAYNE SUPPLY.

THE WHITE CASTLE CRAVE MOBILE WILL BE AT KROGER SATURDAY, FEBRUARY 1, FROM 11-4. THIS IS A CRUSADE FOR CHILDREN FUNDRAISER FOR THE FIRE DEPARTMENT.

MR. SAM BURGESS, MAIN STREET DIRECTOR, SAID THE ECONOMIC VITALITY COMMITTEE MET LAST WEEK TO REVIEW TWO APPLICATIONS FOR THE RENT SUPPORT PROGRAM.

THE FIRST APPLICANT WAS DANIEL CLYMER, WHOSE BUSINESS IS DOWN HOME CUSTOMS. THE LOCATION OF THE BUSINESS WOULD BE AT 445 MAIN STREET. IT WOULD BE A RETAIL OUTLET SELLING ETCHED AND LASER CUT ITEMS. THE COMMITTEE NOTED THAT THIS WASN'T A NEW BUSINESS. IT IS AN EXPANSION OF A CURRENT BUSINESS, CARROLLTON SHEET METAL. IT WAS ALSO STATED ON THE APPLICATION THAT PAYROLL WOULD BE RAN THROUGH CARROLLTON SHEET METAL. HOURS OF OPERATION IS ONE QUESTION THAT ISN'T ASKED ON THE APPLICATION. MAYOR ADAMS CALLED MR. CLYMER DURING THE MEETING AND ASKED WHAT THE OPERATING HOURS WOULD BE. THEY WOULD BE CLOSED SUNDAY & MONDAY. THEY WOULD BE OPEN 9-6, TUESDAY - THURSDAY. FRIDAY AND SATURDAY HOURS WOULD BE 9-8. THE COMMITTEE FELT LIKE THIS IS A GOOD BUSINESS, BUT IT DOESN'T MEET ALL OF THE CRITERIA FOR THE RENT SUPPORT PROGRAM. THEREFORE, THE COMMITT'EE'S RECOMMENDATION IS 80% FUNDING, OR UP TO \$400/MONTH.

THE SECOND APPLICANT WAS EMILY PRINCE OF THE PAINTING PLACE. THE BUSINESS WOULD BE AT 447 MAIN STREET. SHE WOULD OFFER 2-3 HOURS OF PAINTING OR CRAFTING CLASSES. SHE WOULD HAVE REGULAR HOURS MONDAY - FRIDAY. GROUP PARTIES WOULD BE AVAILABLE, PARTICULARLY IN THE EVENING. SHE ALSO PLANS TO TARGET CORPORATIONS FOR CORPORATE OUTINGS. THERE WOULD ALSO BE PRE-MADE ITEMS AVAILABLE FOR SALE. THE COMMITTEE SAID THE BUSINESS DOESN'T FIT INTO A CATEGORY THAT IS TRYING TO BE ATTRACTED DOWNTOWN. THEY RECOMMEND 80% FUNDING, OR UP TO \$400/MONTH DUE TO CRITERIA NOT BEING MET.

THE MOTION WAS MADE BY COUNCILMAN GORDON AND SECONDED BY COUNCILMAN LOUDEN AND DULY CARRIED TO ACCEPT THE ECONOMIC VITALITY COMMITTEE'S RECOMMENDATIONS FOR DOWN HOME CUSTOM DESIGNS AND THE PAINTING PLACE TO BOTH RECEIVE 80% FUNDING FOR THE RENT SUPPORT PROGRAM.
