#### DISCUSSION OF 911 DRAFT AMENDED ORDINANCE

MAYOR ADAMS SAID THEY HAVE BEEN WORKING ON THE DRAFT FOR QUITE SOME TIME TO COME TO AN AGREEMENT WITH THE COUNTY TO FUND DISPATCH IN AN

EQUAL WAY. HE HAS ASKED JUDGE EXECUTIVE WESTRICK TO SEE WHEN THE FISCAL COURT CAN HAVE A SPECIAL MEETING WITH THE COUNCIL SO THEY CAN GO OVER EACH SECTION OF THE 911 DRAFT AMENDED ORDINANCE. THE MAYOR ALSO SAID IT NEEDS TO BE AN INTERLOCAL AGREEMENT AND RESOLUTION INSTEAD OF AN ORDINANCE. COUNCILMAN LOUDEN QUESTIONED THE SHARING OF EXPENSES FOR HOUSING DISPATCH. THE MAYOR SAID ONE WAY TO BILL FOR UTILITIES WOULD BE TO HAVE NEW METERS INSTALLED. COUNCILMAN HILL SAID THAT WOULD BE AN EXPENSE. COUNCILMAN CRAIG SUGGESTED A FLAT RATE AMOUNT OF \$50-\$100 BE BILLED TO FISCAL COURT EACH MONTH.

#### **NEW BUSINESS**

COUNCILMAN LOUDEN ASKED ABOUT THE GLOBAL PAYMENTS DIRECT CONTRACT FOR CREDIT CARD PROCESSING. ATTORNEY FOR THE CITY, AMY EVERSOLE, SAID THEY ARE STILL WORKING ON A FEW THINGS. GLOBAL PAYMENTS DIRECT HAS WAIVED THE 3 YEAR CONTRACT AND THE LIABLITY OF MAYOR ADAMS. MAYOR ADAMS SAID EVEN IF THEY DON'T CHANGE ANYTHING THE CITY IS ASKING FOR, WE WILL PROBABLY HAVE TO MOVE FORWARD ANYWAY.
